Purpose of the processing :

Names, first names and emails may be communicated, at their request, to the organisers of the ENRIS 2025 conference.

No data is transferred outside the European Union.

Duration of storage of your data: 2 years

Your personal data will be deleted at the end of the ENRIS 2023 conference.

Rights of individuals :

You have the following rights with respect to the use of your data:

- The right to object: you may at any time object to the processing of your data and have the right to withdraw your consent (as appropriate)
- The right to access and rectify your data
- The right to erasure

- The right to restricted use when your data is not necessary or is no longer useful
- The right to portability: to communicate your data to the person of your choice (depending on the case)
